




Actions for Pro-Life Victories on November 3rd!



1. Make sure that you are registered to vote. The deadline for voter registration in Missouri is October 7.
2. Vote in person if at all possible.
 - If you are unable to vote in person, plan now to vote absentee in person.

3. Copy the MRL PAC voter guide or fill out the form below to take with you to the polls.

5. Write letters to local papers in support of pro-life candidates. 
6. Share MRL PAC voter guides, videos and action alerts on social media and email.
-  7. Make copies of MRL PAC voter guides and comparison sheets to mail to family, friends, and members of your church. (See note below.)
8. Volunteer to help an endorsed candidate by calling the campaign office and seeing what kind of volunteer help they need.
9. For loved ones in nursing homes unable to physically go to vote, please assist them in filling out their absentee or mail-in ballot to guarantee that they themselves complete the ballot.
-  10. Call anyone who may have trouble voting or driving. Offer to help them with a ride to the polls or the election board.

Note: Contact the MRL state office about organizing a mailing or a literature distribution to churches in your area. Individuals will need to raise their own money for such mailings, but MRL PAC will provide the voter guides and comparison sheets.

Please do not contact your pastors about either a mailing or a literature distribution. They are not allowed to give you permission one way or the other. It just puts them in a difficult position.
